4. Locations & Playability

4.1. Unfortunately, due to circumstances beyond our control, locations of the tournament may change at the last minute.

4.2. Likewise, due to circumstance beyond our control, including weather, game times for the tournament are liable to change at the discretion of the tournament director.

4.3. Changes in the above may be communicated through phone call, text, email or notice through our Rainout Line.

4.4. Game times for a tournament may begin as early as 8 am on Thursday and run through Sunday evening.

4.5. In the event of a holiday weekend, games may be played through Monday.

5. Tournament Cancellation Policy

5.1. Request must be submitted in writing by the head coach of record as listed on USSSA.

5.2. If your team pays for a tournament and then voluntarily withdraws from said tournament before the payment deadline (typically the Friday, 1 week before the tournament begins), a refund will be issued for the entry, less an administrative fee of 25%.

5.3. If your team pays for a tournament and then voluntarily withdraws after the tournament payment deadline (typically the Friday, 1 week before the tournament begins), then no refund will be issued.

5.5. If, for any reason not covered above, a refund is issued, a 15% administrative fee will be assessed.

5.6 Refunds may take up to 30 days from the date of the tournament to be processed.

6. Rain out Refund Policy

6.1. Powerstrike Fastpitch and the facilities we play at, will make all reasonable efforts to run all tournaments to completion. If, circumstances beyond our control, cause an event to be called before completion, the below refund policy applies:

6.1a. 3 GAME GUARANTEE

- **0 Games Started:** Full refund less 15% administrative fee
- **1 Game Started:** 40% refund
- **2 Games Started:** NO REFUND

6.1b. 4 GAME GUARANTEE

- **0 Games Started:** Full refund less 15% administrative fee
- **1 Game Started:** 60% refund
- **2 Games Started:** 40% refund
- **3 Games Started:** NO REFUND

6.1c. **5 GAME GUARANTEE**

- **0 Games Started:** Full refund less 15% administrative fee
- **1 Game Started:** 60% refund
- **2 Games Started:** 40% refund
- **3 Games Started:** 20% refund
- **4 Games Started:** NO REFUND

6.1d. **6 GAME GUARANTEE**

- **0 Games Started:** Full refund less 15% administrative fee
- **1 Game Started:** 60% refund
- **2 Games Started:** 40% refund
- **3 Games Started:** 20% refund
- **4 Games Started:** NO REFUND

6.1e. All USSSA Sanction Berths and points will be awarded.

6.1f. Trophies will be awarded.

6.1g. Team Rosters must be online on USSSA.com.

6.1h. Refunds may take up to 30 days from the date of the tournament to be processed.
